Call to Order: The meeting was called to order by President Jameson at 7:01 p.m.

Public Comment: No public comment.

**Approval/Amendment of the Agenda:** Director Kubash requested to add Election 2024 as another Other Business item. On a motion from Trustee Donovan and seconded by Trustee VanSweden, the agenda was adopted as amended.

After discussion, the Board requested that this card type be excluded from borrowing Discovery Kits and that the loss rate be evaluated at year's end. On a motion from Trustee Sidney and seconded by Trustee Calvaruso, the Board approved the Library Card service policy update as amended.

*Leadership Academy 2024* – On a motion from Trustee Donovan and seconded by Trustee VanSweden, the Board approved Head of Adult Services Beth attending the Leadership Academy program offered through the Michigan Library Association.
